LAURENCE CRAPO HONORED

"I had a surprise reception at the Seniorfest Dinner tonight. I was honored as Veteran of the Year by the Women's Chamber of Commerce for my service aboard the USS JOHN R PIERCE during the Cuban Missile Crisis in 1962. My family was there and I received a certificate from my Texas State Representative with a Texas State Flag and another certificate from Congressman Kenny Marchant and a US flag flown over the Capital in Washington, D.C. A few years back Kevin Costner told of our story in the movie "Thirteen Days". In addition I was given a gift of \$20's.

I was overwhelmed and surprised. After Stopping the MARCULA dead in the water, the folks back home thought this would trigger the nuclear war. We sent a joint boarding party with the USS JOSEPH P. KENNEDY. I was portside of the bridge manning a machine gun. I later got the first reports of the inspection and sent copies to the fleet. We allowed the vessel to proceed to Havana, as they were carrying army trucks. We were sent down to Colon, Panama were we picked up 36 ships coming thru the canal, loaded with Green Berets, Rangers and Marines for an invasion of Cuba. We escorted the ships toward Cuba south. As we closed in, Washington told us to slow down. President Kennedy made an agreement with the Soviets to pull our missiles out of Turkey and the Reds would pull the Missiles out of Cuba. Our ship had a direct line to the White House. As a result our action avoided a catastrophe.

Sometime later, I was transferred to the USS BORIE DD704."

Laurence was a PN3 (Personnel Man 3rd Class) and was aboard the Pierce 1960-1962.
